Subject:- Revised norms/guidelines regarding Post Matric Scholarship Scheme for SC/ST Students studying or taking admission in Panjab University, Chandigarh and its Regional Centers, for the academic session 2017-18.

## (A) Punjab State only:-

(i) All Normal Courses:-

The Vice-Chancellor with the approval of the Syndicate meeting vide paragraph No.71(XIV) dated 8,9,2012 and 6,10,2012 and approval of the Senate meeting vide paragraph No. XCVII(R-43) dated 20,01,2013 has ordered:-

"That the Vice-Chancellor, in anticipation of the approval of the Syndicate/Senate, has allowed that the <u>tuition fee and other non-refundable charges</u> be not taken from the SC/ST students belonging to <u>Punjab State</u> at the <u>time of admission</u> for various courses other than self financing courses of the Panjab University and its Regional Centers from the session 2012-13."

(ii) All Self-financing courses:-

The Vice-Chancellor with the approval of the Syndicate meeting vide Paragraph 98 held on 1/15/28/29 May, 2016 and Senate meeting vide Paragraph No. XXXV held on 9.10.2016 approved:-

"That SC/ST students of Punjab State who are eligible for Post Matric Scholarship (i.e. whose family income is less than of equal to 2.5 lakh only) studying or taking admission in Self-financing courses of Panjab University and its regional centers, be allowed to pay only 25% of the total admission fee (including tuition fee and other non-refundable charges) at the time of admission, to the respective teaching departments of Panjab University and its regional centers, from the academic year 2016-17."

The Chairpersons/Directors of all the Teaching Departments are requested to get all the formalities completed by SC students, eligible for PMS Scheme, belonging to Punjab State, and their Post Matric Scholarship (PMS) application forms along with supporting documents duly checked, verified and countersigned (with office seal) may be sent to the SC/ST Cell by 30/09/2017 along with an undertaking/statement of claim that:-

- (i) In the case of normal courses: Tuition fee and other non refundable charges have not been charged (in case of normal courses) by the department at the time of admission in academic year 2017-2018.
- (ii) In case of Self-financing courses- Only 25% of total tuition fee and other non-refundable charges have been charged by the department at the time of admission.

So that PMS application forms can be processed and sent to the welfare department in due time.

Note:- It is pertinent to mention here that these eligible PMS students (who belong to SC/BC category) getting the benefit of fee exemption through PMS scheme of Govt. of India are required to fill up the Post Matric Scholarship application form (mentioning therein admission fee\* and examination fee for both the semesters of the academic session) which is mandatory for all the students (Fresh and Renewal students of Normal & Self-financing courses), so that the students

and/or University may not suffer any financial loss while claiming fee reimbursement from the respective funding state/agency.

\*Admission fee: This includes tuition fee and other non-refundable charges including examination fee of both the semesters of academic session 2017-18.

### (B) States other than Punjab:-

In case of SC/ST/BC students who are studying and or taking admission in the teaching departments of Panjah University and its regional centers and belongs to States other than Punjah (i.e. Chandigarh, Haryana, Himachal Pradesh, J&K, Rajasthan, UP etc.) who are also eligible or applied for Post Matric Scholarship (PMS) through online, the Chairpersons/Directors of the teaching departments are requested to get all the formalities completed by the eligible students belonging to states other than Punjab and send the hardcopy of their application forms to SC/ST Cell by 30/09/2017 duly checked, verified and countersigned (with office seal) along with an Undertaking/Statement of claim that the total tuition fee and other non-refundable charges have been received by the department at the time of admission, so that their application forms can be processed and sent to the quarter concerned well in time.

Note:- The students who belong to SC/ST/BC category, belonging to states other than Punjab and paid the full fee (i.e. tuition fee and other non-refundable charges) at the time of admission (Fresh & Renewal for Normal and Self-financing courses) they are required to fill up the Post Matric Scholarship application form (mentioning therein admission fee\* and examination fee for both the semesters of the academic session) which is mandatory for all the students who want to take the benefit of reimbursement of claim of fee paid by them at the time of admission. Their fee will be reimbursed by the respective/concerned state government directly into their account of the student.

\*Admission fee includes tuition fee, and other non-refundable charges including examination fee of both the semesters of academic session.

 The applicant must have taken admission into the higher class/course in any of the Govt./Govt. aided/Professional Educational Institutions/colleges/Schools.

6. Application for the benefit under the scheme must be supported by requisite documentary proof such as the employer certificate from the department where his/her parents are employed to the effect that his/her parents is/arc salnikaramchari in the office/Board/Corporation of the Chandigarh Administration/other Governments/Private Sectors at least for the last one year, the copy of 10th or 12th pass certificate, copy of birth certificate etc. The authenticity of the employer certificate is subject to verification by Chandigarh Scheduled Castes backward Classes and Min. Fin. Dev. Corpo. Ltd. from the concerned issuing authority.

7. In case Private Safai Karamcharies, a certificate should be issued by the Managing Director, Chandigarh Scheduled Castes Backward Classes & Min.Fin.Dev. Corpn. Ltd on the basis of Self declaration by the applicant with supporting documents which should be verified by the Field Officer/Committee of the Corporation or

recommended by the area Councilor.

However, with a view to ensuring timely recoveries, the loan is applicable for incritorious students among the Backward Classes, who have got admission on merit under non-payment seats in the Colleges/Institutes having excellent track record for placement of the successful students.

It is suggested that the students having less than 60% in their eligibility exam, may not be considered for Education Loan. Further, the NBCFDC also offers loans for students pursuing higher professional courses in the Universities abroad. However, the courses and the Universities should be recognized by Government of India. For this purpose, the Financing Corporation/Banks on behalf of students are required to get clearance regarding status of University from Association of India University (AIU) at the address below.
