The Committee constituted by the Vice Chancellor to decide on the course of action to be taken for submission of fake/ forged medical certificates by the students, held on 30.1.2017 at 12.30 p.m., the extract duly approved by the Syndicate in its meeting held on 25th February, 2017 (Item No. 22) is as follows:

1. "In case the medical certificate/ document/evidence submitted by the student is found to be forged or fake, the student shall be liable to pay a fine of Rs.15,000/- and shall be debarred from appearing in the current semester examination (in case a student has already appeared in the current semester examination, the result of the same shall stand cancelled) and the student shall not be allowed admission in the next semester also. The student can seek readmission in the same semester, in which he/she submitted fake/forged certificate, next year.

2. In case of annual system of examination, apart from a fine of Rs. 15,000/-, the student shall be debarred from appearing in the year-end examination (in case the student has already appeared in the year-end examination, the result of the same shall stand cancelled) and the student shall not be allowed admission in the next year also. The student can seek readmission in the same year, in which he/she submitted fake/ forged certificate, after a gap of full one academic session."
